**I. THE 39TH IISL COLLOQUIUM**  
**BEIJING, CHINA**  
**7-12 OCTOBER 1996**

The 39th Colloquium on the Law of Outer Space was held in Beijing, China, from 7 to 11 October 1996. The Colloquium was attended by some 60 participants, and about 50 papers were registered. A report of the Colloquium will appear in the next issue of the Journal of Space Law.

The following sessions were held:

Session 1: The Legal Status of Property Rights on the Moon and Other Celestial Bodies. Chairman: Dr. He Qizhi (China). Rapporteurs: A. Markkanen and S. Heikkilä (Finland)

Session 2: Cases and Methods of Dispute Settlement in Space Law. Chairman Prof. K.-H. Böckstiegel (Germany). Rapporteur: D. Crowther (France)

Session 3: Legal Aspects of Sharing Benefits from the Conduct of Space Activities. Chairman: Dr. S. Doyle (USA). Rapporteurs: B. Coebergh and J. Richer (USA)

Session 4: Other Legal Subjects. Co-Chairmen: Prof. T. Kosuge (Japan), Dr. E. Fasan (Austria). Rapporteurs: Y. Hashimoto (Japan) and Abu Bakar Munir (Malaysia).

A Scientific-Legal roundtable was organized in cooperation with the IAA on "The future of space telecommunications".

- One session in Beijing was again devoted to a discussion of all colloquium topics, and was presided over by the President of the Institute. For this purpose, the first and second sessions were combined. Each chairman gave a report on the issues that were raised during his ses-

sion, and each rapporteur briefly commented on those issues, after which an extensive open discussion took place. This session was particularly well attended, and will be repeated in Turin.

- The 5th Manfred Lachs Space Law Moot Court Competition was held on 10 October. The University of Helsinki (Finland) and the University of Wyoming (USA) competed in a case concerning Liability for commercial space endeavors (Parlivia vs. Californium *et al.*), written by Pamela Meredith. The University of Helsinki team won the competition. Its members were Satu Heikkilä and Anna Markkanen. The members of the University of Wyoming team were Bastiaan Coebergh and Joseph Richer. The Institute was particularly grateful to the ICJ Judges who had accepted the invitation to judge the finals, i.e. Judge Chr. Weeramantry, Judge V. Vereshchetin and Judge G. Herczegh. The University of Beijing hosted the competition and offered a reception after the finals. The Chinese Foreign Ministry also sponsored the competition, and KLM Royal Dutch Airlines and Air China provided tickets for the judges. AUSMIISL and ECSL supported the competition by sending the winning teams of the preliminaries to Beijing. The case and the written briefs will be published in the IISL Proceedings.

For the sixth competition, please refer to the section on the 1997 IISL Colloquium.

- The Board meeting was held on Monday 7 October, and the General Assembly of Members on Friday 11 October. The following paragraphs summarize the proceedings of these two meetings.

### i. Activities & Publications

- **Standing Committee on the Status of Space Law Treaties**: the 1996 report of this Committee was presented and will be published in the proceedings.
- **Committee on definitional issues in space law** and **Committee on dispute settlement and cases regarding activities in outer space**: no significant progress has been made by these committees, and the Board will reconsider their mandates at the next Spring meeting.
- **Proceedings of the Beijing Colloquium** will be published by the AIAA; members and authors may buy a copy at a reduced price.
- A **1996 Brochure** describing the IISL, its programs and officers was published with the support of Dr. Kosuge; a copy is enclosed with this newsletter.
- An overall **author and subject index of IISL proceedings**, as a joint UN/IISL effort, has been published. The IISL President will mail a copy to all paid-up IISL members.
- **UN Highlights in Space Report**: the IISL has again prepared a report on recent developments in space law for the UN annual review of developments in international cooperation and space law.
- **New Membership list**: all paid-up IISL members will find the new updated list with this issue of the newsletter. **Members are urgently requested to communicate any changes to the secretariat, and also to inform the secretariat of their e-mail address if not yet included!**
- **Membership Certificates**: the Board will pursue the question of issuing certificates of membership to paid-up IISL members at its next Spring meeting.

### ii. Financial situation

- The report of the Treasurer, Dr. Lafferranderie, shows the following balance as per 30 September 1996:
  - I. **French Francs Account** with Barclays Bank, Paris: FF 42.989,77 (i.e. an increase of FF 13.843,93 as compared to last year)
  - II. **US Dollar Account** with Barclays, Paris: US\$ 30.534,43, most of which is placed in

short term bonds (i.e. an increase of US\$ 6.726,18 as compared to last year).

- The Institute is grateful for the annual support of the Centre National d'Etudes Spatiales (France), ESA and the Academy of Sciences (Russia).

- An estimated budget for the period October 1996-September 1997 has been established.

### iii. Dues

The dues status on 30 September 1996 was as follows: of the 355 registered members, 207 are fully paid up. Ten members are in arrears of their 1995 and 1996 dues, and 22 of their 1996 dues. There are still 116 members who have never paid any dues, and the Board of Directors has decided to send them one last letter, and to remove them to a list of former members if payment is not received before the Board's Spring meeting. Members who are in arrears of dues for 1995 and/or 1996 will find a **reminder** enclosed with this Newsletter. Those who have paid until 1996 will receive a request for payment of 1997 dues with this Newsletter.

### iv. Elections

- In December 1996, **IISL Secretary Tanja Masson-Zwaan** will be moving to Singapore. She will remain Secretary of the Board, but several tasks will be maintained at the Paris office, such as the mailing of newsletters, bank matters, etc. Also the Paris address will remain the official mailing address of the IISL. Therefore, **Ms Daphne Crowther**, the Secretary of ESA's European Centre of Space Law, was appointed by the Board to serve as **Assistant to the Board**. Her appointment has been approved by ESA, and the General Assembly has endorsed this solution. - The **terms of office of the following Directors expired in 1996**: N. Jasentuliyana (President) (UN/Sri Lanka), G. Catalano Sgrosso (Italy), A. Cocca (Argentina), G. Gál (Hungary) and M. Komar Kantaatmadja (Indonesia). In addition, the new Statutes provide for 12 Directors while there are only

11 at present, and thus one additional vacancy should be filled.

Session 2: Concepts of Space Law and the Outer Space Treaty

Chairmen: E. Galloway and G. Catalano Sgrosso

*A session to explore the concepts of law contained in the Outer Space Treaty and the elaboration of those concepts as contained in the subsequent international treaties and agreements in space law*

Session 3: Applications & Implementation of the Outer Space Treaty

*A session to explore the problems and realities of applying and implementing the Outer Space Treaty and the basic provisions of space law therein*

Chairmen: S. Doyle and G. Lafferranderie

Session 4: The Future Applications of the Outer Space Treaty

*Examination of the Treaty from a 21st century perspective; should the Treaty be amended, supplemented or otherwise reinforced?*

Chairmen: K.-H. Böckstiegel and A. Terekhov

The possibility of a special event (a dinner for example) for the IISL on the occasion of the 30th anniversary of the Treaty (10th October 1997), and the 40th anniversary of the Colloquium on the Law of Outer Space is being investigated.

The Secretary is the Coordinator for all four sessions. Members who are interested in serving as rapporteurs are invited to contact the Secretary before March 15, 1997.

**ii. Practical Arrangements**

- All authors must submit an abstract for approval by the Board, before an IISL paper is accepted for the colloquium. Also, the chairmen may invite a few papers to cover all aspects of the subject.

- The abstract must comply with the instructions provided on page 32 of the 1997 IAF Call for Papers which was sent to all IISL Members. Each abstract must be accompanied by the abstract information form on page 33 of the Call for Papers.

- Abstracts must reach the IAF by 1 March 1997 at the latest! \_

- The decision on acceptance will be made at the Spring meeting, in April 1997. Authors will be notified of acceptance of their papers in May 1997.\_

- The full text of the papers must be typed in two columns, in English, on regular paper. Precise instructions regarding lay-out etc. will be provided by the AIAA, who will also mail an author's instruction kit and indicate the deadline for submitting the paper for publication. - Authors should bring ± 75 copies of their papers for distribution at the Colloquium.

- The aim will be to grant a minimum of 15 minutes for presentation of papers by each speaker.

- The Board intends to organize a separate discussion session on Friday 10 October. For this purpose, two of the other sessions will be combined into one session. The Secretary will send a note to all authors of accepted papers one month before the colloquium, asking them to notify the secretariat whether they will attend the colloquium.

- Acceptance of a paper for the Colloquium does not imply publication in the Proceedings.

- An author whose paper is published in the Proceedings, as well as all IISL Members, may buy the Proceedings at a reduced price.

**iii. 6th Manfred Lachs  
Space Law Moot Court Competition**

The Case for the 1997 competition has been finalized and distributed to universities, and contact has been made with authorities in Turin for the organization of the competition. The case, which deals with Very High Resolution (VHR) remote sensing systems, was written by *Harry Tuinder, Marco Ferrazzani* and *Frans von der Dunk*. Copies may be obtained from the Secretariat.

AUSMIISL and ECSL will again organize preliminary competitions in the US and Europe in the Spring of 1997. In addition, an Asian Regional Preliminary is being considered. The Board will further study the matter and discuss it at its Spring meeting. The Board will take a close look at the current rules and propose modifications to accommodate other regional rounds, and will also set the standard rules with which all regionals must comply.

### **III. THE 41ST IISL COLLOQUIUM MELBOURNE, AUSTRALIA, 28 SEP.- 2 OCT. 1998**

Regarding the topics for the 1998 Colloquium, Members are strongly encouraged to suggest topics to the Board; suggestions must be received in Paris by **15 March 1997**, since the Board will decide on these topics at its Spring meeting. Suggestions which have already been made are:

- Legal and policy aspects of Confidence Building Measures using space technology,
- The 30th anniversary of the Rescue Agreement,
- Legal aspects of navigation satellites,
- Legal Aspects of Sharing Benefits from the Conduct of Space Activities.
- Institutional approaches to managing space resources.

### **IV. COPUOS MEETINGS**

The dates of the 1997 sessions of the COPUOS are as follows:

- 1-18 April '97: Legal Sub-Committee

All sessions will take place in Vienna. Members who would like to serve as official IAF observer for one of these sessions are requested to contact the Secretary as soon as possible, but in any case before mid-January.

### **IISL WORKSHOP**

As in previous years, the IISL will organize a symposium, on the same topic as that of the Turin IISL Colloquium, for the delegates and staff of the Legal Subcommittee session; the Coordinator of the 1997 program is Dr. E. Fasan.

## **V. MISCELLANEOUS**

- The IAF General Assembly has approved the new IISL Statutes as amended in Oslo in 1995, at its meeting in Beijing.

- IISL Member Dr. L. Haeck is involved in a new project by the Ecole Polytechnique and the Royal Military College, to create a multimedia course on space law funded by the Department of National Defense (Canada). Dr. Haeck was further appointed by the Canadian Space Agency to act as interface with the European Centre for Space Law at ESA, Paris.
