#### What is the "United States Code"?

The United States Code is the official codification of Federal statutory law.

### Layers of Government in USA

## The United States Code contains only FEDERAL statutes.

- Local Government (towns, counties, etc)
- State Government (e.g., Virginia ... Maryland)
- Federal Government (U.S.A. as a whole; the nation)

## United States Code 51 subject matter titles

#### positive law title:

The actual title itself is enacted; the title itself is a Federal statute.

#### non-positive law title:

The title is an editorial compilation of Federal statutes.
