You will find in this newsletter a status report of the progress accomplished so far.

We would like to thank Mark Sundahl for his valuable contribution the past couple of years and we are pleased that he is staying very active as Co-Coordinator of the IISL Colloquium.

IISL STRATEGY BOARD ENDORSED DECISIONS STATUS REPORT

At the occasion of the 50th Anniversary of the Institute, the IISL Executive Secretary suggested the Board of Directors to conduct a Strategy Meeting so it could address short, medium and long-term goals as well as the vision for the IISL. It would also provide some guidelines and goals for the work of the various committees. The Board agreed and Corinne Jorgenson prepared and led the two Strategy Meetings in the Spring and Fall 2010. The discussion emulated a lot of debate and many points were raised. Recommendations were voted upon during the Board of Directors meetings in the Fall 2010 and Spring 2011. A year later, we would like to provide a status report on the implementation of the various Board decisions.

1. Relevance of the IISL

It was agreed that the IISL should take an active role in showing leadership in the development of space law in all its aspects: international, private, commercial, contractual, etc. The IISL needs to assume this leadership. The Institute has a unique position and can be a major player to solve the legal problems that will confront mankind in the further exploration and use of outer space.

Board Decision: Increase marketing efforts so the Institute has a wider and more efficient reach. This effort includes creating an IISL brochure and all Board Members to provide their CVs for the website.

Status: The work on an IISL brochure is in progress and PJ Blount is now leading this project. All Board Members CVs are available on the IISL Website since last year.

Board Decision: Look into what communities and institutions the Institute wants to target, what big meetings/conferences around the globe the Institute wants to associate with, create partnerships, etc.

Status: A report was made and presented to the Board and follow-on actions are currently in progress.

Board Decision: Expand the IISL contributions to the UN. This could include participating at a higher level in the Capacity building workshops and other workshops organized. The Institute could make a statement/paper and encourage membership applications within OOSA/COPUOS.

Status: The IISL President is inviting systematically in her annual report and during her oral presentation, the delegates to join the IISL as members and several have followed through. A number of Board members participated in the Capacity building workshop in Thailand.

Recently, the IISL officially proposed the contribution of the Institute to the Expert Group D on Regulatory Regimes and Guidance for Actors in the Space Arena of the Working Group on the Long-Term Sustainability of Outer Space Activities of the Scientific and Technical Subcommittee of COPUOS.

Board Decision: Create a “speakers’ bureau” not limited to Board members where experts can be identified.

Status: The IISL has created an online interactive membership database where members can describe their field of interest and expertise. Many reminders were sent the past couple of years to members to activate their profile.

2. Membership

Board Decision: Create two separate surveys to individual members and institutional members.

Status: An extensive survey has been completed last year by Jose Monserrat Filho and Sylvia Ospina. A total of 16% of the membership, 67 out of 404 members, participated in the survey. This was the first ever consultation of IISL members. Many of the replies and suggestions were taken up in the recent revisions of the statutes and bylaws. It was suggested that a survey could be done every 5 years.

Board Decision: Create a Membership Committee to streamline applications for membership and expand the membership of the Institute.

Status: A Membership Committee was created last year, co-chaired by Patricia Sterns and Ranjana Kaul. This committee needs more members so if you are interested to join please email Ranjana Kaul at the newly created dedicated email address: membership@iislweb.org.

Board Decision: Organize a regional standalone “Practitioners Forum”.

Status: A report was presented on the possibilities of an IISL “Practitioners Forum.” More work and volunteers are needed and this is currently a work-in-progress.

3. Financial

The Board highlighted that in order to keep growing the Institute needs to bring some financial return through its activities, including symposia and colloquia. The board also discussed the matter of expanding fundraising

and sponsorships opportunities.

Board Decision: Streamline the accounting system

Status: During the past year, there has been a major revision of the Institute’s finances and the new Treasurer has introduced a new accounting system. The membership list has been cleaned up and incorporated into this new accounting system. All the records are being digitized.

Board Decision: Create a sponsorship committee

Status: Although there have been several calls to the membership to participate in IISL committees, there have been no volunteers so far to participate actively in such a committee. The IISL Treasurer with a team of officers will work on creating IISL sponsorship packages.

4. Proceedings

The main point that was highlighted was that the IISL did not own the copyright of its proceedings. The Editor of the Proceedings, Corinne Jorgenson also highlighted that there was a need for a Publications Committee.

Board Decision: Create a Publications Committee
A Publications Committee was created last year co-chaired by Joanne Gabrynowicz and Haifeng Zhao.

Board Decision: Look into other publishing options.

Status: This year, a team composed by Marietta Benkö, Tanja Masson-Zwaan, Corinne Jorgenson and Joanne Gabrynowicz investigated the possible options and presented its recommendations to the Board. It was decided that Eleven International Publishing would publish the IISL Proceedings. The IISL now retains the copyright of the book. The 2011 IISL Proceedings is the first volume published by Eleven International Publishing.

5. IISL Visibility at IAC

It was highlighted that the IISL contributes 7% to the technical program of the IAC and the International Academy of Astronautics (IAA) 33%. So both organisations represent approximately 40% of the IAC Congress. In this context, the Institute and its members should take leverage of this significant level of contribution aiming at increasing the IISL recognition and visibility.

In addition, it was underlined that the Institute does not receive a financial return to its contribution while it also brings a non-negligent part of the registered participants and a non-negligent part of the program preparation workload, between the IISL Colloquium, the joint sessions with IAA and IAF, the Plenary Event and the Moot Court World Semi-Finals and Finals.

Board Decision: Ensure the visibility of the Institute at the IAC.

Recommendations include making sure the IISL is represented suitably in all IAC marketing materials, ensuring it is correctly presented and perceived as an independent organization, ensuring the title of the Institute's Colloquium keeps its official title with IISL and its reference number, ensuring that the visibility of the IISL President and Board of Directors is equivalent to that of other organisations, etc.

Status: The Executive Secretary has been negotiating with IAF this past year on these various items.

We are delighted to announce that the 2011 IISL Proceedings, the first volume published by Eleven International Publishing, is now published. This is an exciting moment for the International Institute of Space Law and we hope you will enjoy the new format.

As the Institute offers much more than just the colloquium papers, it is a continuous challenge to get some papers on time for publication. The Editor, Corinne Jorgenson requests all authors, Colloquium session chairs as well as IISL program committee chairs to please provide all the available papers, symposia programs and reports to her within three months following the events.

For the Naples IISL Colloquium, we ask all authors to send a PDF AND WORD version of their final paper (which can be an updated version of the manuscript) in ONE column instead of two, with footnotes (not endnotes) and in 11 pt Times New Roman **before 5 November** to Mariska Duindam of Eleven International Publishers at M.Duindam@budh.nl. IISL CONFERENCES AND EVENTS

IISL/ECSL Symposium at COPUOS, March 2012

On the occasion of the 51st Session of the Legal Subcommittee of the UNCOPUOS last March, the IISL and ECSL organized the annual Symposium for delegates of the Legal Subcommittee. The topic was "Transfer of ownership of space objects: Issues of responsibility, liability and registration". The papers of this symposium will be published in the 2012 IISL Proceedings. Conference 'Space Law and Contemporary Issues: A Focus on the Asia-Pacific Region', Hyderabad, India, 24 June 2012

A one-day conference was organized in cooperation with NALSAR University of Law after the Asia Pacific round of the Manfred Lachs moot court. Sessions addressed 'Policy and Legal Approaches for Regional Space Cooperation', 'Long Term Sustainability of Outer Space Activities', 'Regulatory Regimes for Outer Space Activities', 'Space Law and Contemporary issues', and 'Peaceful Uses of Outer Space - Trends and Challenges'. The presentations were compiled in a publication that will be released soon.

2nd IISL-IAA Space Law and Policy Symposium, Toulouse Space Show, France, 25-28 June 2012

The IISL co-organized the successful 2nd IISL-IAA Space Law and Policy Symposium held in Toulouse at the occasion of the Toulouse Space Show. The Symposium focused on the Sustainable Use of Outer Space, and featured a Keynote and four sessions, addressing 'Institutional parameters: observers' perspectives', 'Sustainable use of the radio spectrum', 'Responding to Space Situational Awareness and space debris', and 'Transposing sustainability into effective legal solutions'.
